

Dance Tech & Talent (DT&T) Company Contract and Requirements

CLASS REQUIREMENTS

Apprentice Company - (5.75 Total hrs. per week)

- 1 Company class per week (1.50 hrs.)
- 1 Ballet classes per week (1.25 hrs.)
- 1 Lyrical class per week (1hr.)
- 2 other classes of their choosing

Senior Company - (7.5 Total hrs. per week)

- 1 Company class per week (1.5 hrs.)
- 2 Ballet classes per week (1.5 hrs. each)
- 1 Lyrical class per week (1hr.)
- 2 other classes of their choosing

- All members are required to attend **ALL** Classes, Rehearsals, Performances and Competitions

COMPANY EXPENSES

- **Company Fee** - a **one time non-refundable** fee of **\$300 (Due the 1st week of classes)** and is in addition to your **regular monthly tuition**
 - This fee covers all additional rehearsals, performances, and required choreography expenses.
 - It does **NOT** include fee'd performances, costumes, guest artist fees or extra choreography
- **Competition fee** - half of the competition fee will be due in November and the remaining half will be due in January
- **2 costumes** - Company Members are guaranteed 2 Company dances and will need to purchase the 2 costumes totaling **\$180 (Due September 1st)**
- **Monogramed dance jacket** - approximate cost of **\$110** (only if you do not already have one)
- **Mode Dion make-up kit** - approximate cost of **\$70** (only if you do not already have this kit) - **modedion.com**
- Company members are responsible to have all tights, shoes, and additional garments needed:
 - **Leotard** - solid black (preferably thin strap)
 - **Leggings/Yoga pants** - solid black, lower calf/ankle length (no visible logo's)
 - **Shorts** - solid black dance shorts ("bike" or "booty" shorts)
 - **Tights** - Capezio **stirrup** tights #1961 - caramel color
 - **Shoes** - jazz Bloch "Pulse" slip-on #S0470L - tan color
 - **Lyrical shoes** - Capezio "Pirouette II" in nude canvas (style no. H061): split sole shoe
- **Drop Fee** - **\$250** if you drop out before the end of the year
(This may only be waived with Beau & Kristin's approval for medical or extenuating circumstances)
- **Late Fee** - There will be a 10 day grace period for all fee's. After 10 days, all fees will be considered late and will accrue a \$15 late fee.

****If any other dances are set (i.e. Solo's/special duet/trio or group dances) separate costume, choreography, and competition fee's will incur.****

At times Company classes may be cancelled in lieu of a performance and there will be no make-up class offered as the performance takes the place of class. This will be kept to a minimum.
